## Section D: Property Maintenance

As an operator of a rental business you are responsible for the maintenance and standards at the property. This includes, but is not limited to the Rental Housing Licensing By-law, Property Standards By-law, Lot Maintenance By-law, and Snow & Ice Removal By-law.

**Grass cutting:** Grass must be cut to less than 15.24cm (6 inches) in the front, side and rear yard. It is the property owner's responsibility to ensure that this standard is met.

**Keeping the property clean of litter and debris:** The property must be kept clear of litter and debris at all times. It is the property owner's responsibility to ensure that this standard is met.

**Garbage, recycling & green bins:** Garbage, Recycling, and Green Bins must be stored behind the front of the building and in a secure enclosure. Garbage collection is bi-weekly and recycling and green bin collection is weekly. Tenants should be informed of the collection standards and frequency.

**Snow clearing/salting/sanding:** Snow accumulation or icy conditions at the property and abutting public sidewalks are required to be cleared within 24 hours of a snow fall or icing event. It is the property owner's responsibility to ensure that this standard is met.
